a) to acquire treasury shares in accordance with Section 65 (1) no. 4 and no. 8 as well as (1a) and (1b) AktG both via the stock exchange and over-the-counter to the extent of up to 10% of the share capital, also excluding the proportionate right of sale that may be associated with such an acquisition (reverse exclusion of pre-emptive rights), b) in accordance with Section 65 (1b) AktG, to decide on a type of sale for the sale or use of treasury shares other than via the stock exchange or by means of a public offer, applying mutatis mutandis the provisions on the exclusion of shareholders' subscription rights, c) to reduce the share capital by redeeming these treasury shares without a further resolution of the Annual General Meeting.
